- Registration of a domain name may be preceded by obtaining the option for registration of the domain name, after completing conditions specified in the Regulations of the option for registration of a domain name (hereinafter: Regulations), published on the NASK's Internet website, assigned for registration of Internet domain names.

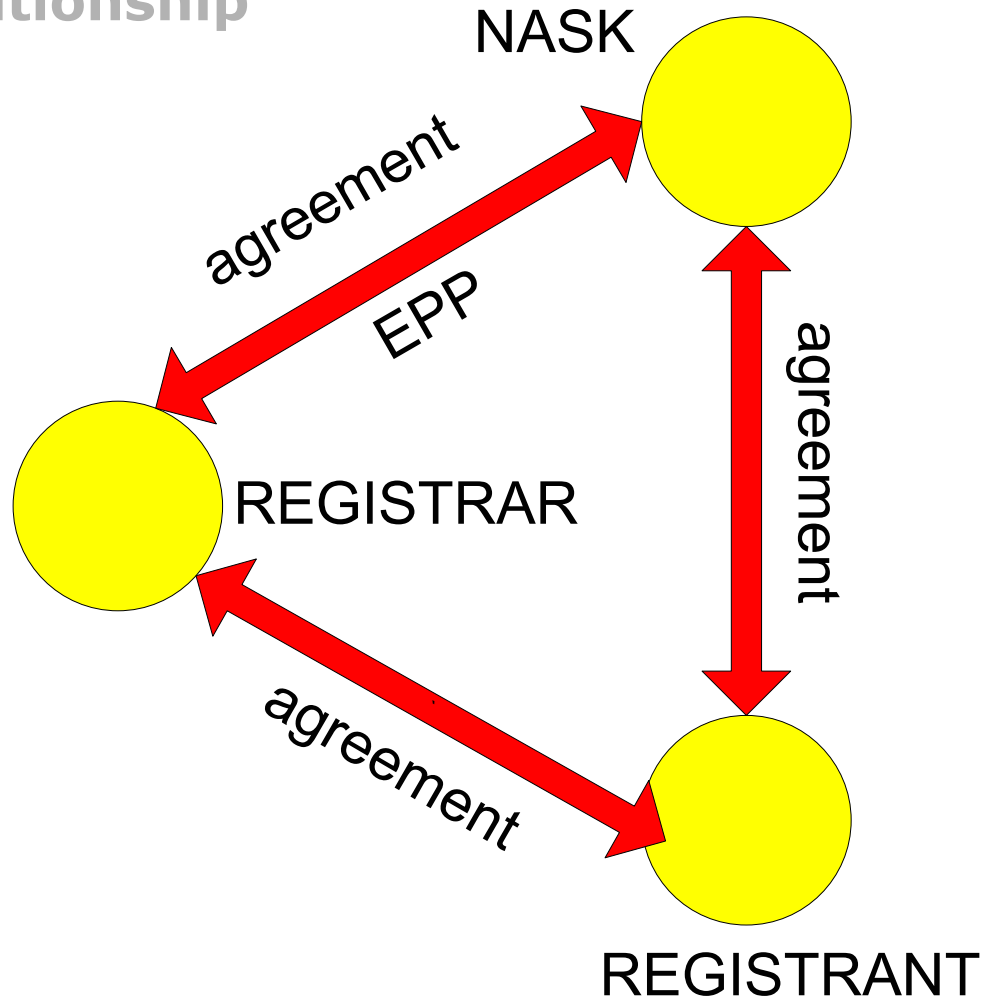

Basic rules

- **Synonyms: OPTION, Reservation, "Back order", Future,**
- **FCFS rule for Options,**
- **No sunrise,**
- **OPTION is valid for 3 years,**
- **No direct reservations,**
- **Only one OPTION for one domain name (no waiting list) is allowed,**
- **Registered domain names only can be reserved,**
- **No Registrant data in WhoIs,**
- **WhoIs shows „Option“ or „No Option“ flag for each domain name.**

Legal relationship



Options – new service for NASK's customers

Procedure: Reserved domain name is registered

- **Domain name B is registered,**
- **Registrar A buys OPTION for domain name B for the registrant C,**
- **Domain B expires and NASK books (for 30 days) domain B for Registrar A; Registrar A is able to register domain B for Registrant C,**
- **If domain B is not registered within 30 days, domain B became free for registration to every Registrar (FCFS).**

Options – new service for NASK's customers

Procedure: Domain name does not expire.

- Registrar A buys OPTION for domain name B for the registrant C,
- If the domain B does not expire in the three years period, OPTION expires after this time period,
- NASK/Registrar DOES NOT return OPTION fee.

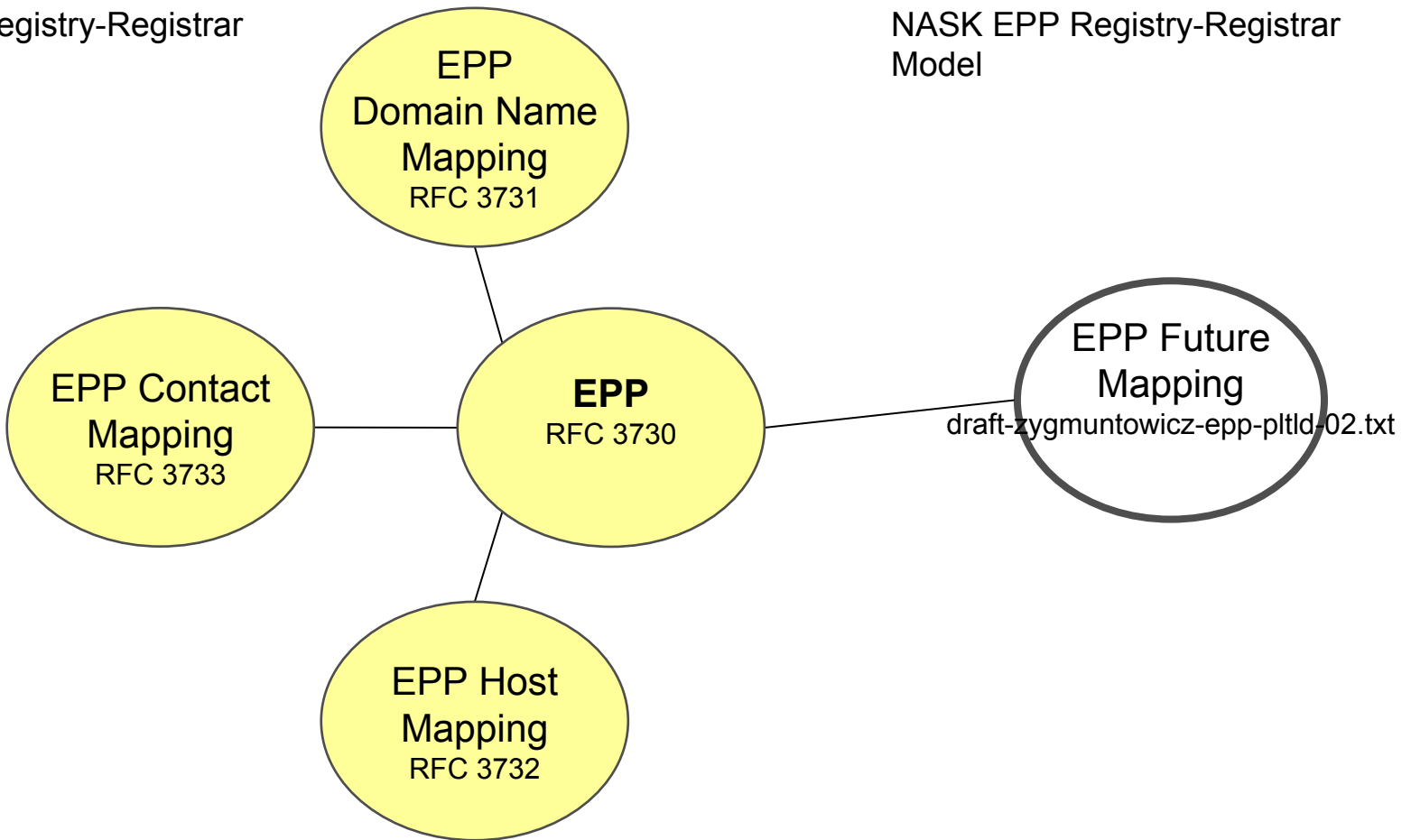

Model

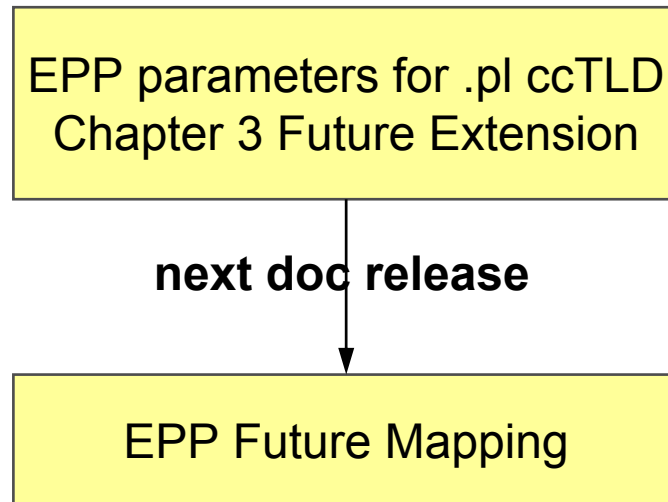
NASK EPP Registry-Registrar

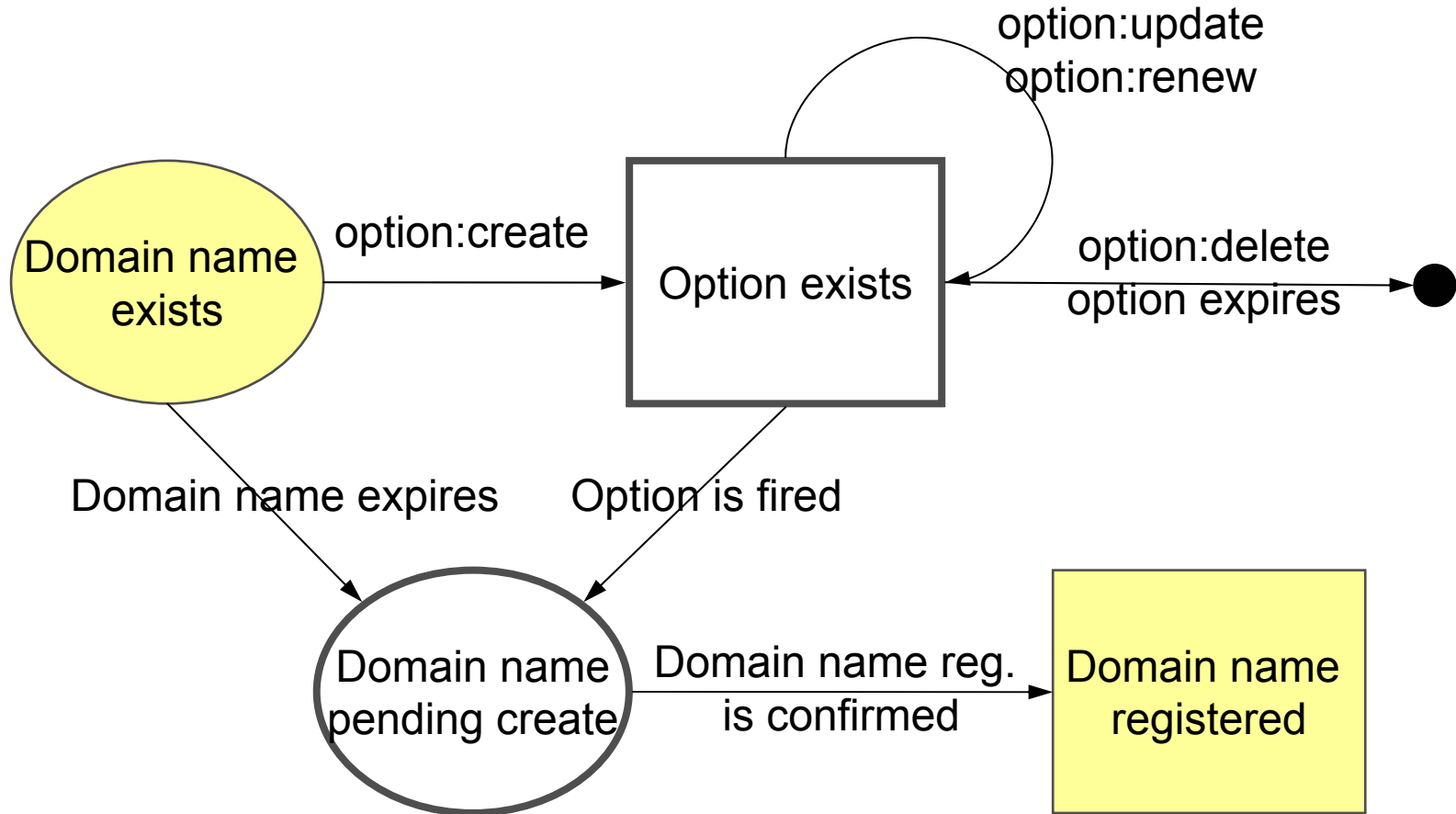

Option Object Life Cycle






